The CAN Help! Program increased the number of items distributed in 2024 versus 2023. Over 100,000 items, including perishable and nonperishable foods, candies, personal hygiene items, clothes, birthday and Christmas gifts, and more, were distributed to residents of three senior living facilities in Norfolk, Hampton, and Virginia Beach, one battered woman shelter, patrons of one community center in Newport News, VA. serving disadvantaged youth, senior citizens, single parents, and residents of seven Newport News, Virginia Beach, Keysville, VA, Tampa Bay, and Miami, FL nursing homes. This program also helped seniors reset and service their cell phones, budget their finances, apply for grants to offset medical expenses, apply for SSI disability, navigate the medical system, and gave grants for direct medical expense recovery, utility payments, and rent stipends to seniors.

Operation T.I.D.Y. benefited many individuals by teaching them the importance of integrity through community service, financial literacy, and entrepreneurship coaching. Many of these adults were fulfilling court-appointed community service hours and faced learning and physical disabilities. The program, run by CAN, aimed to prevent homelessness and assisted participants in improving their integrity, managing personal finances, organizing their time, communicating effectively, and developing business management skills. Additionally, the program helped individuals navigate the legal system, enabling them to complete court-ordered restitution and community service requirements.
